
As announced in MOF's Committee of Supply ("COS") 2024, Tender Lite will be implemented from end Apr 2024. It will cover tenders with estimated procurement value not exceeding \$1 million for general goods and services first. MOF will be reviewing Tender Lite for ICT and construction buys in following years. Under Tender Lite, there would be fewer contract conditions compared to typical tenders.

The streamlined set of contract conditions for Tender Lite aims to create a more gradual progression from Quotations (simple and few conditions) to Tenders (more and complex conditions), so that businesses which have difficulties in complying with the full Tender requirements now, can consider participating in Tender Lite first. This is to allow businesses easier access to smaller value Government Tenders and build their capabilities before competing for higher value Tenders.


# A. Search for Tender Lite Opportunities

### 1. Click on Advance Search




2. Under Opportunity Type, select *Tender Lite*.

Note: If you have selected Opportunity Type as Tender, both Tender and Tender Lite opportunities will be listed.




3. If there are *Tender Lite* opportunities, they will be tagged and listed as *Tender Lite*.




# B. Browse opportunities

1. Click Go to browse for Tender Lite opportunities.



- 2. Browse for opportunity tagged as Tender Lite.
- 3. Under *Narrow Results* section, you can further perform search on the listed opportunities. The Opportunity Type will list all the published opportunity type. If there is no Tender Lite opportunity published at the time of search, Tender Lite will not be listed as one of the opportunity type for selection.



## Frequently Asked Questions (FAQs)

### 1. What is Tender Lite?

Tender Lite is a sub-category of Tender with estimated value of more than \$90,000 and not exceeding \$1 million, excluding prevailing GST. Tender Lite aims to create a more gradual progression from Quotations to Tenders. Tender Lite has fewer and simpler conditions which are arranged into three distinct sections. Section (i) comprises standard contract clauses, Section (ii) comprises sector specific clauses, and Section (iii) contains all other clauses specific to a particular tender. Tender Lite will be implemented from end Apr 2024 onwards starting with general goods and services buys, and will be introduced to Infocomm Technology (ICT) and Construction buys in following years.
